### 5.3. Advice for firefighters

may cause gas receptacles to rupture. Cool endangered receptacles with water spray jet from a protected position. Prevent water used in emergency cases from entering sewers and drainage

systems.

If possible, stop flow of product.

Use water spray or fog to knock down fire fumes if possible.

If leaking do not spray water onto container. Water surrounding area (from protected position) to

contain fire.

Move containers away from the fire area if this can be done without risk.

# SECTION 7: Handling and storage

#### 7.1. Precautions for safe handling

Safe handling of the gas receptacle

Safe use of the product

: Do not breathe gas.

Avoid release of product into atmosphere.

The substance must be handled in accordance with good industrial hygiene and safety procedures.

Only experienced and properly instructed persons should handle gases under pressure.

Consider pressure relief device(s) in gas installations.

Ensure the complete gas system was (or is regularily) checked for leaks before use.

Do not smoke while handling product.

Use only properly specified equipment which is suitable for this product, its supply pressure and

temperature. Contact your gas supplier if in doubt.

Refer to supplier's container handling instructions.

Do not allow backfeed into the container. Protect cylinders from physical damage; do not drag, roll, slide or drop.

When moving cylinders, even for short distances, use a cart (trolley, hand truck, etc.) designed to

transport cylinders.

Never use direct flame or electrical heating devices to raise the pressure of a container.

Do not remove or deface labels provided by the supplier for the identification of the cylinder contents. Suck back of water into the container must be prevented.

Containers should not be stored in conditions likely to encourage corrosion.

Container valve guards or caps should be in place.

Containers should be stored in the vertical position and properly secured to prevent them from

falling over.

Stored containers should be periodically checked for general condition and leakage.

Keep container below  $50^{\circ}\mathrm{C}$  in a well ventilated place.

Store containers in location free from fire risk and away from sources of heat and ignition.

Keep away from combustible materials.
